## **NOTICE OF NOMINATIONS MEETING**

April 27, 2016

Dear Brothers and Sisters:

In accordance with Article VI, Section 1 of the Uniform Local Union Constitution, there will be a SPECIAL CALLED MEETING, to be known as the NOMINATIONS MEETING of Laborers' Local Union No. 220. This meeting will be held at the American Legion Bakersfield Post 26, 2020 H St. Bakersfield, CA 93301, on **Saturday, May 14, 2016 at 10:00 A.M.**

The purpose of this meeting is for the Nominations of Officers for the ensuing three (3) year term which begins July 2016. Nominations will be opened at that time for all offices as listed below.

In addition, Nominations of Convention Delegate shall be conducted immediately following Nomination of Officers as follows:

Convention Delegate (3)

Convention Delegates will be provided with a per diem allowance and transportation stipend to and from the Convention by the International Union. Local Union 220 will reimburse each delegate for cost incurred while in attendance at the Convention. Reimbursement will be calculated as follows:



- (1) Wages and benefits of all full time Local Union staff and Officers who will become a duly elected or appointed delegate.
- (2) Currently employed union members who are elected delegates will be provided a stipend equivalent to their current wage and benefits package while in attendance of the Convention.
- (3) Elected delegates who are on the out of work list will be provided stipend equivalent to the Group I rate in addition to the benefits package while in attendance of the convention.

Nominees for any of the above offices must be present at the NOMINATION MEETING. All members properly nominated shall be nominated by two (2) other members in good standing and should be present at the time of nomination, unless absent on business of the Local Union, District Council, or International Union, or excused for just cause by a vote of the membership of the Local Union and shall indicate immediately upon nomination whether it is accepted or declined.


Please be advised that immediately following the Nomination Meeting, the Judges of Election will qualify all candidates. All candidates are required to appear.

To be eligible to run for office, each candidate must present one (1) of the following items to the Judges of Election:

- (1) Birth Certificate (original or certified copy) issued by a state, country, municipal authority or outlying possession of the United States bearing an official seal.
- (2) U.S. passport (unexpired or expired)
- (3) Alien Registration Receipt Card with photograph (Green Card)
- (4) Any other document that establishes lawful permanent residency or that is recognized by the Immigration and Naturalization Services (I.N.S.)

No guests or visitors will be allowed to attend this meeting. You must present your Union Membership card and be in good standing in order to attend.
